- C. To cooperate to the fullest extent with the Engineer and other Agents of the owner toward fulfillment of the contract undertaken.
- D. To solicit and accept bids and/or quotations only from firms who subscribe to the principles of the Code of Ethics.
- E. To make all payments promptly within the terms of the contract.
- F. To observe and foster the highest standard of safety and working conditions for employees.
- G. To the continuation and further development of social and ethical principles by members and others associated with them in the underground construction industry and a constant adherence to the democratic processes and principles of freedom guaranteed to all persons in the Constitutions of the United States and the State of Michigan.
- H. To take joint action as an Association, if necessary, in defense of the member and/or their employee's rights as guaranteed to them by the laws of the United States and the State of Michigan.
- I. To establish realistic wage schedules for employees commensurate with their ability so that they may enjoy the dignity to which they are entitled.
- J. To participate actively in the training of skilled trades people for the purpose of having such skilled personnel available to members of this Corporation.
